Management is responsible for the accompanying financial statements of the Ocean High and Port Authority of Nassau County (a not for profit Special District chartered by the Legislature of the State of Florida), which comprise the balance sheet- cash basis as of March 31, 2024, and March 31, 2023 and the related statement of operations- cash basis for two quarters ended March 31, 2024, and two quarters ended March 31, 2023 and one quarter ended March 31, 2024 and one quarter ended March 31, 2024. The financial statements will not include a statement of cash flows.

We conducted the engagement in accordance with Statements on Standards for Accounting and Review Services (SSARS) promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the financial statements nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by management. Accordingly, these financial statements are not designed for those who are not informed about such matters.
